The annual NCCHA Conference draws health and wellbeing professionals from institutions of higher education across the North Central region of the United States (Iowa, Minnesota, North Dakota, South Dakota, Wisconsin). Attendees represent all areas of college health: medical providers, nurses, health promotion staff, registered dietitians, social workers, counselors, directors, and administrative staff.

ELIGIBILITY

Companies that meet the ACCME definition of an “ineligible company (below)” may become sponsors, but will not receive an ad in the program, company information on a promo item, and will have their sponsorship acknowledged in text only (no branded exposure/corporate logo). Ineligible companies are those whose primary business is producing, marketing, selling, re-selling, or distributing healthcare products used by or on patients.

ACHA/NCCHA is restricted by continuing education accrediting bodies from providing “ineligible” companies with branding or promotional opportunities in exchange for sponsorship funds. An ACCME-defined “ineligible company” is a company that produces, markets, re-sells, or distributes health care goods or services consumed by, or used on, patients. This includes companies with products/services related to pharmaceuticals, medical supplies, diagnostic/testing equipment and supplies, contraceptive devices, etc.
